**CALL TO ORDER/PLEDGE OF ALLEGIANCE**

**PUBLIC HEARING ON THE ALTERNATIVE EXPENDITURE LIMITATION-HOME  
RULE OPTION**

Town Manager Anna Flores provided background information explaining the Council held the advertised public hearing on the proposed alternative expenditure limitation at the April 10, 2018 Special Meeting. This is the second public hearing for community input on this expenditure proposal. This is a spending issue not a taxation or revenue issue, and does not allow a tax increase. Once this public hearing is held it is recommended the Council adopt the Resolution No. 18-12 which proposes the alternative expenditure limitation be submitted to the voters at August 28, 2018 Primary Election.
